## **General Notes**

### Note 1:

HM Land Registry will accept the discharge by arrangement where the registered charge is not in the name of Yorkshire Building Society. An abstract of any relative Transfer of Engagement is with the deeds.

### Note 2:

In the case of the former Barnsley Building Society, Chelsea Building Society and Norwich and Peterborough Building Society the charge is now registered at HM Land Registry in the name of Yorkshire Building Society (trading as Barnsley Building Society, Chelsea Building Society or Norwich and Peterborough Building Society, respectively).

### Note 3:

In the case of Egg Banking Plc, the charge is now registered at HM Land Registry in the name of Yorkshire Building Society.
