The Society and the Existing Lender include their respective successors in title and anyone to whom all or any of their rights under the Society's Standard Security or (as applicable) the Existing Standard Security may be transferred entirely or in part and either outright or by way of security only.
3. The Society has agreed to lend to the Borrower the Advance upon the security of the Society's Standard Security.
4. The Existing Lender consents to the granting of the Society's Standard Security and agrees that all sums due in terms of the Existing Standard Security and all charges, expenses, outlays and interest which may arise thereunder shall be postponed to and rank after the Advance and all sums due in terms of and secured by the Society's Standard Security.
5. The priority rights hereby conferred shall not be affected by any variation or partial release of the Existing Standard Security or the Society's Standard Security or any fluctuation in the sums secured thereby.
6. The Society shall not be entitled in respect of any further advances it may make after the date of this deed to the Borrower to any priority over the security constituted by the Existing Standard Security.

RANKING AGREEMENT - SCOTLAND
